- On all new water heaters, the vent pipe must be double-walled. If gas fired and installed in a garage, the heater must be 18 inches above the floor and a pan under the water heater.
- The installation of gas yard lines must be 12 inches underground. If steel pipe is used, it must be wrapped or coated. All gas lines must have a cut-off valve at the house.
- Drains, waste/vent systems must be schedule 40 PVC/DWV only (FOAMCORE IS NOT ALLOWED).
- Gas test must be performed with a low pressure test of 10 PSI holding on the line. Red top valves are required on all appliances using gas.
- City Ordinance prohibits the use of galvanized pipe and fittings for potable water systems.
- All external water piping and pipe in outside walls must be insulated.
- Hose bibs must be supplied by a vacuum breaker and strapped to the structure if CPVC piping is used.
- Within the limits of Texas City, no wet venting is allowed.
